The Complainant, Veronica Kilpatrick, a Supervising
Special Investigator of the State of California, for Statement of
Issues against STEPHEN FRANK WHITE (Respondent) is informed and
alleges in her official capacity as follows:

1. On or about June 6, 2016, Respondent applied to the
Bureau of Real Estate of the State of California for a real
estate salesperson license.

1 2. On or about February 1, 2007, in the State of
2 Florida, County of Miami-Dade, case no.F06-024609A, Respondent
3 was convicted of ecstasy trafficking in violation of statute no.
4 893.135(1)(K)2A, 777.011 and traffick conspiracy in violation of
5 statute no. 893.135(5), 777.011, 777.04(3), felonies.

7 3. On or about February 1, 2007, in the State of
8 Florida, County of Miami-Dade, case no. F06-016479, Respondent
9 was convicted of cocaine possession in violation of statute
10 893.13(6)(A), controlled substance possession in violation of
11 893.13(6)(A), and concealed weapon carrying in violation of
12 790.01(1), felonies.

14 4. The matters alleged in Paragraphs 2 and 3 are
15 substantially related to the duties, functions and qualifications
16 of a real estate licensee.

17 5. The matters alleged in Paragraphs 2 and 3 are
18 grounds to deny Respondent's application under Sections 480(a)(1)
19 and 10177(b) of the California Business and Professions Code.


21 The Statement of Issues is brought under the provisions

23 of the State of California and Sections 11500 through 11528 of
