In part, Respondent was sentenced to 3 years of formal probation, 45 days of community service, 1 day of jail, and pay various fines and fees. Said crime bears a substantial relationship to the qualifications, functions, or duties of a real estate licensee under Section 2910, Title 10, Chapter 6, California Code of Regulations.

The crime of which Respondent was convicted as alleged above constitutes cause for denial of Respondent's application for a real estate license under California Business and Professions Code sections 475(a)(2), 480(a), and 10177(b).
