STIPULATION AND WAIVER

I, LENNY LISWANTY ("Respondent") do hereby affirm that I have applied to the Bureau of Real Estate ("Bureau") for a real estate salesperson license, and that to the best of my knowledge I have satisfied all of the statutory requirements for the issuance of the license, including, but not limited to, the payment of the fee therefor.

18 I acknowledge that by entering into this Stipulation and Waiver, I am stipulating that the 19 Real Estate Commissioner ("Commissioner") has found grounds that justify the denial of the 20 issuance of an unrestricted real estate salesperson license to me. I agree that there are grounds to 21 deny the issuance of an unrestricted real estate salesperson license to me pursuant to 22 Sections 475(a)(2)-(3), 480(a)(1)-(2), 480(d), 10177(a) and 10177(b)(1) of the Business and 23 Professions Code ("the Code") for conviction for violation of California Code Penal Code 24 Section 488 (Petty Theft), a misdemeanor, and my failure to reveal the conviction on my license 25 application.

I hereby request that the Commissioner in his discretion issue a restricted real estate
salesperson license to me under the authority of Sections 10100.4 and 10156.5 of the Code. I

understand that any such restricted license will be issued subject to the provisions and limitations of Sections 10156.6 and 10156.7 of the Code.

I understand that by my signing of this Stipulation and Waiver, provided this Stipulation and Waiver is accepted and signed by the Commissioner, the Commissioner will not file a Statement of Issues based on the grounds herein, and I am waiving my right to a hearing and the opportunity to present evidence at the hearing to establish my rehabilitation in order to obtain an unrestricted real estate salesperson license.

⁸ I agree that by signing this Stipulation and Waiver, the conditions, limitations, and
⁹ restrictions imposed on my restricted license, identified below, may be removed only by filing a
¹⁰ Petition for Removal of Restrictions ("Petition") with the Commissioner, and that my Petition
¹¹ must follow the procedures set forth in Government Code Section 11522.

I further understand that the restricted license issued to me shall be subject to all of the
provisions of Section 10156.7 of the Code and to the following limitations, conditions and
restrictions imposed under authority of Section 10156.6 of the Code:

 The restricted license shall not confer any property right in the privileges to be exercised including the right of renewal, and the Commissioner may by appropriate order suspend the right to exercise any privileges granted under the restricted license in the event of:

a. Respondent's conviction (including a plea of nolo contendere) of a crime that bears a substantial relationship to Respondent's fitness or capacity as a real estate licensee; or

 b. The receipt of evidence that Respondent has violated provisions of the California Real Estate Law, the Subdivided Lands Law, Regulations of the Commissioner, or conditions attaching to the restricted license.

2. Respondent shall not be eligible to petition for the issuance of an unrestricted real estate license nor the removal of any of the conditions, limitations, or restrictions attaching to the restricted license until three (3) years have elapsed from the date of
