24	Division 4 of the California Business and Professions Code ("Code"), as a real estate
25	salesperson (License ID 01385403). Respondent's license is scheduled to expire on October 15,

(CRIMINAL CONVICTION)

3.

On or about June 21, 2017, in the Superior Court of California, County of San Bernardino, Case No. MWV17011650, Respondent was convicted on a plea of no contest for violation of Vehicle Code section 4462.5 (display invalid registration), a misdemeanor. Respondent was placed on summary probation for a period of 2 years subject to certain terms and conditions.

4.

In aggravation, on or about August 24, 2010, in the Superior Court of California, County of Los Angeles, Case No. 0WW00905, Respondent was found guilty and convicted by a jury for violation of Penal Code section 243(e)(1) (battery against a person with whom defendant had a dating relationship), a misdemeanor. Respondent was placed on summary probation for 3 years, subject to certain terms and conditions, including 16 days in Los Angeles County Jail (credit given for 8 days actual custody and 8 days good time/work time), performing 20 days of Cal Trans, obeying the protective order issued in this case, enrolling in and successfully completing a 52 week domestic violence treatment program, and payment of various fees and fines.

5.

The convictions, as described in Paragraphs 3 and 4 above, bear a substantial relationship under Section 2910, Title 10, Chapter 6, California Code of Regulations to the qualifications, functions or duties of a real estate licensee.

6.

The crime of which Respondent was convicted, as described in Paragraph 3 above, constitutes cause under Sections 490 and 10177(b) of the Code for the suspension or revocation of the license and license rights of Respondent under the Real Estate Law.

(COSTS OF INVESTIGATION AND ENFORCEMENT)

7.

California Business and Professions Code section 10106, provides, in pertinent part, that in any order issued in resolution of a disciplinary proceeding before the Bureau of Real Estate, the Commissioner may request the administrative law judge to direct a licensee found to have committed a violation of this part to pay a sum not to exceed the reasonable costs of the investigation and enforcement of the case.
