3	On or about October 19, 2018, in the Superior Court of California, County of
4	Orange, case no. 18NF0345, Respondent was convicted of California Vehicle Code sections
5	23153(a) (driving under the influence with bodily injury to another) and 23153(b) (driving with
6	a blood alcohol level with 0.08 percent or more with prior felony within 10 years), both
7	felonies. In part, Respondent was sentenced to serve five (5) years of formal probation, serve
8	180 days in jail, attend and complete an 18-month Multiple Offender Alcohol Program, pay
9	restitution, and pay various fines and fees. These crimes are substantially related to the
10	qualifications, functions, or duties of a real estate licensee under Section 2910, Title 10, Chapter
11	6, California Code of Regulations.
12	4.
13	In aggravation, on or about May 21, 2013, in the Superior Court of California,
14	County of Orange, case no. 13NM00573, Respondent was convicted of California Vehicle
15	Code sections 23152(a) (driving under the influence) and 23152(b) (driving with a blood
16	alcohol level of 0.08 percent or more), both misdemeanors. In part, Respondent was sentenced
17	to serve three (3) years of informal probation, attend and complete a 3-month First Offender
18	Alcohol Program, and pay various fines and fees.

20	The crimes of which Respondent was convicted, as described in Paragraph 3,
21	above, constitute cause under California Business and Professions Code sections 490 and
22	10177(b) for the suspension or revocation of the license and license rights of Respondent under
23	the Real Estate Law.
