- 1. The filing of this Declaration shall be deemed as my petition for voluntary surrender.
- 2. It shall also be deemed to be an understanding and agreement by me that I waive all rights I have to require the Commissioner to prove the allegations contained in the Accusation filed in this matter at a hearing held in accordance with the provisions of the Administrative Procedure Act (Government Code Sections 11400 et seq.), and that I also waive other rights afforded to me in connection with the hearing such as the right to discovery, the right to present evidence in defense of the allegations in the Accusation and the right to cross-examine witnesses.
- 3. I further agree that upon acceptance by the Commissioner, as evidenced by an appropriate order, all affidavits and all relevant evidence obtained by the Department in this matter prior to the Commissioner's acceptance, and all allegations contained in the Accusation filed in the Department Case No. H-41667 LA, may be considered by the Department to be true and correct for the purpose of deciding whether to grant re-licensure or reinstatement pursuant to Government Code Section 11522.
- 4. I freely and voluntarily surrender all my licenses and license rights under the Real Estate Law.
- 5. I further understand and agree to pay the Commissioner's reasonable cost for the audit which led to this action in the amount of \$8,025.78, prior to and as a condition to reinstatement pursuant to Government Code section 11522. I am aware that if I petition for reinstatement in the future, that payment of the audit costs will be a condition of reinstatement

2	Commissioner's reasonable cost, the Commissioner may use the estimated average hourly salar
3	for all persons performing audits of real estate brokers, and shall include an allocation for travel
