DECLARATION

My name is DONALD THEODORE SPEAKMAN and I am the designated officer of MERIT ONE LENDING, INC. ("MERIT ONE"), which is currently licensed as a real estate corporation and/or has licensed rights with respect to said license. I am authorized and empowered to sign this declaration on behalf of MERIT ONE. I am acting on behalf of MERIT ONE, in this matter. MERIT ONE is represented by Lucy McAllister, Esq.

In lieu of proceeding in this matter in accordance with the provisions of the Administrative Procedure Act (Sections 11400 et seq., of the Government Code), MERIT ONE wishes to voluntarily surrender its real estate licenses issued by the Department of Real Estate ("Department"), pursuant to Business and Professions Code ("Code") section 10100.2.

I understand that MERIT ONE, by so voluntarily surrendering its licenses, can be relicensed as a broker, or issued a new mortgage loan originator endorsement, only by petitioning

for reinstatement pursuant to Section 11522 of the Government Code. I also understand that by so voluntarily surrendering its licenses, MERIT ONE agrees to the following:

- 1. The filing of this Declaration shall be deemed as its petition for voluntary surrender.
- 2. It shall also be deemed to be an understanding and agreement by MERIT ONE that it waives all rights it has to require the Commissioner to prove the allegations contained in the Accusation filed in this matter at a hearing held in accordance with the provisions of the Administrative Procedure Act (Government Code sections 11400 et seq.), and that it also waives other rights afforded to it in connection with the hearing such as the right to discovery, the right to present evidence in defense of the allegations in the Accusation and the right to cross-examine witnesses.
- 3. It shall also be deemed to be an understanding and agreement by MERIT ONE that upon acceptance by the Commissioner, as evidenced by an appropriate order, all affidavits and all relevant evidence obtained by the Department in this matter prior to the Commissioner's acceptance, and all allegations contained in the Accusation filed in Department Case No. H-41837 LA, may be considered by the Department to be true and correct for the purpose of deciding whether to grant relicensure or reinstatement pursuant to Government Code section 11522.
- 4. MERIT ONE LENDING, INC. freely and voluntarily surrenders all of its licenses and license rights under the Real Estate Law.

DECLARATION

Respondent.

My name is ROGER DUZIAN, and I am currently licensed as a real estate salesperson and/or have license rights with respect to said license. I am representing myself in this matter.

In lieu of proceeding in this matter in accordance with the provisions of the Administrative Procedure Act (Sections 11400 et seq., of the Government Code), I wish to voluntarily surrender my real estate license(s) issued by the Department of Real Estate ("Department"), pursuant to Business and Professions Code Section 10100.2.

I understand that by so voluntarily surrendering my license(s), I may be relicensed as a broker or a salesperson, or issued a new mortgage loan originator endorsement, only by petitioning for reinstatement pursuant to Section 11522 of the Government Code. A copy of the Commissioner's Criteria of Rehabilitation is attached hereto. If and when a petition application is made for reinstatement of a surrendered license or endorsement, the Real Estate Commissioner will consider as one of the criteria of rehabilitation, whether or not restitution has been made to

any person who has suffered monetary losses through "substantially related" acts or omissions engaged in by me, Roger Duzian, whether or not such persons are named in the investigation file in this case. I also understand that if and when a petition application is made for reinstatement of a surrendered license, I will be required to pay part or all of the investigation and enforcement costs incurred by the Department in this matter. I further understand that by so voluntarily surrendering my license(s), I agree to the following:

- 1. The filing of this Declaration shall be deemed as my petition for voluntary surrender.
- 2. It shall also be deemed to be an understanding and agreement by me that I waive all rights I have to require the Commissioner to prove the allegations contained in the Accusation filed in this matter at a hearing held in accordance with the provisions of the Administrative Procedure Act (Government Code Sections 11400 et seq.), and that I also waive other rights afforded to me in connection with the hearing such as the right to discovery, the right to present evidence in defense of the allegations in the Accusation and the right to cross-examine witnesses.

I further agree that upon acceptance by the Commissioner, as evidenced by an appropriate order, all affidavits and all relevant evidence obtained by the Department in this matter prior to the Commissioner's acceptance, and all allegations contained in the Accusation filed in the Department Case No. H-41837 LA, may be considered by the Department to be true and correct for the purpose of deciding whether to grant relicensure or reinstatement pursuant to Government Code Section 11522.
- 4. I freely and voluntarily surrender all my licenses and license rights under the Real Estate Law.
