In lieu of proceeding in this matter in accordance with the provisions of the 20 Administrative Procedure Act (Sections 11400 et seq., of the California Government Code), I 21 wish to voluntarily surrender my real estate license issued by the Department of Real Estate 22 ("Department") pursuant to California Business and Professions Code section 10100.2. 23 I understand that by so voluntarily surrendering my license, I may be relicensed as 24

1. The filing of this Declaration shall be deemed as my petition for voluntary surrender.

- 2. It shall also be deemed to be an understanding and agreement by me that I waive all rights I have to require the Commissioner to prove the allegations against me in Citation No. C-3-23-0406-003 at a hearing held in accordance with the provisions of the Administrative Procedures Act (California Government Code sections 11400 et seq.), and that I also waive other rights afforded to me in connection with the hearing, such as the right to discovery, the right to present evidence in my defense, and the right to cross-examine witnesses.
- 3. I further agree that upon acceptance by the Commissioner, as evidenced by an appropriate order, all affidavits, and all relevant evidence obtained by the Department in this matter prior to the Commissioner's acceptance, and all evidence supporting the allegations described above, may be considered by the Department to be true and correct for the purpose of deciding whether to grant licensure, relicensure, and/or reinstatement pursuant to California Government Code section 11522 and/or a similar code section.
- 4. Prior to issuance of any new or reinstated license, I shall pay the Department for the citation and fine, which is a total of \$1,500.00. This amount is only due upon issuance and/or reinstatement of a real estate license to Respondent.
- 5. A copy of the Commissioner's Criteria of Rehabilitation is attached hereto. If and when a petition application is made for licensure, relicensure, and/or reinstatement, the Commissioner will consider as one of the criteria of rehabilitation whether or not restitution has been made to any person who has suffered monetary losses through "substantially related" acts or omissions by me.
- 6. I freely and voluntarily surrender all my license(s) and license rights under the Real Estate Law.
