20 The Real Estate Commissioner of the State of California (hereinafter
21 "Commissioner") has caused an investigation to be made of DIVIDENDS XIII CAPITAL's

DIVIDENDS XIII CAPITAL is currently licensed as a corporate real estate broker, Department of Real Estate (“DRE”) license ID 01962875.

II

The rights and privileges of DIVIDENDS XIII CAPITAL (California Secretary of State ID C3661481) are currently suspended by the California Secretary of State pursuant to the provisions of the California Revenue and Taxation Code. Said suspension is a violation of Section 10177(f) of the Code in that it would have constituted grounds for the denial of DIVIDENDS XIII CAPITAL’s corporate real estate broker license under Section 2742(c) of the Regulations. According to California Secretary of State Certificate of Status dated January 15, 2022, DIVIDENDS XIII CAPITAL has been suspended since April 1, 2021.

III

TRACIE CAROLYN LOVE (DRE license ID 01291515) is currently licensed as the designated officer of record of DIVIDENDS XIII CAPITAL. As such, pursuant to Code Section 10159.2, TRACIE CAROLYN LOVE was and/or is responsible for the supervision and control of the activities conducted on behalf of the corporation by its officers and employees as necessary to secure full compliance with the Real Estate Law (Section 10000, et seq., of the Code), including the supervision of salespersons licensed to the corporation in the performance of their acts for which a license is required.

V

NOW, THEREFORE, DIVIDENDS XIII CAPITAL AND ITS SUCCESSORS IN INTEREST ARE HEREBY ORDERED TO DESIST AND REFRAIN from performing any acts for which a real estate license is required until DIVIDENDS XIII CAPITAL has presented evidence satisfactory to the Commissioner that DIVIDENDS XIII CAPITAL is no longer subject to the suspension described in Paragraph II.


