25	upon this Stipulation and Waiver. I also understand that by filing the Statement of Issues in this
26	matter the Commissioner is shifting the burden to me to make a satisfactory showing that I meet all
27	the requirements for issuance of a real estate salesperson license. I further understand that by

entering into this Stipulation and Waiver I will be stipulating that the Commissioner has found that
 I have failed to make such a showing, thereby justifying the denial of the issuance to me of an
 unrestricted real estate salesperson license.

I hereby admit that the allegations of the Statement of Issues filed against me are true and
correct and request that the Commissioner in his discretion issue a restricted real estate salesperson
license to me under the authority of Section 10156.5 of the Business and Professions Code ("the
Code").

I am aware that by signing this Stipulation and Waiver, I am waiving my right to a hearing and
the opportunity to present evidence at the hearing to establish my rehabilitation in order to obtain
an unrestricted real estate salesperson license if this Stipulation and Waiver is accepted by the
Commissioner. However, I am not waiving my right to a hearing and to further proceedings to
obtain a restricted or unrestricted license if this Stipulation and Waiver is not accepted by the
Commissioner.

I agree that by signing this Stipulation and Waiver, the conditions, limitations, and restrictions
imposed on my restricted license, identified below, may be removed only by filing a Petition for
Removal of Restrictions ("Petition") with the Commissioner, and that my Petition must follow the
procedures set forth in Government Code Section 11522.

I further understand that the restricted license issued to me shall be subject to all of the
 provisions of Section 10156.7 of the Code and to the following limitations, conditions and
 restrictions imposed under authority of Section 10156.6 of the Code:

 The restricted license shall not confer any property right in the privileges to be exercised including the right of renewal, and the Commissioner may by appropriate order suspend the right to exercise any privileges granted under the restricted license in the event of:

The receipt of evidence that Respondent has violated provisions of the California b. 1 Real Estate Law, the Subdivided Lands Law, Regulations of the Commissioner or 2 conditions attaching to the restricted license. 3 Respondent shall not be eligible to petition for the issuance of an unrestricted real estate 2. 4 license nor the removal of any of the conditions, limitations, or restrictions attaching to 5 the restricted license until four years have elapsed from the date of issuance of the 6 restricted license to Respondent.
