16	The Complainant, Veronica Kilpatrick, a Supervising Special Investigator of the
17	State of California, for cause of Accusation against TODD ELLIOTT CAMARENA
18	("Respondent"), also known as Todd Camarena, Todd E. Camarena, Todd Elliot Camarena,
19	alleges as follows:
20	1.
21	The Complainant, Veronica Kilpatrick, a Supervising Special Investigator of the
22	State of California, makes this Accusation in her official capacity.
23	2.
24	Respondent presently has license rights under the Real Estate Law, Part 1 of
25	Division 4 of the California Business and Professions Code ("Code"), as a real estate
26	salesperson (License ID 02030709). Respondent's license expiration date was April 3, 2021;

however, pursuant to Governor Newsom's Executive Order No. N-83-20, Respondent's license

expiration date was extended until June 30, 2021. Respondent's license expired on June 30, 2021. The Department of Real Estate retains jurisdiction over the lapsed license pursuant to Section 10103 of the Code.

## FIRST CAUSE OF ACCUSATION

## (CRIMINAL CONVICTIONS)

3.

On or about November 2, 2020, in the Superior Court of California, County of Riverside, Case No. RIF1902258, Respondent was convicted on a plea of guilty for violation of Penal Code section 594(a) (vandalism), a misdemeanor. Respondent was placed on summary probation for thirty-six (36) months on certain terms and conditions, including, in part, commitment to the custody of the Riverside County Sheriff for sixty (60) days, with credit for time served of two (2) actual days, and two (2) days pursuant to Penal Code section 4019, for a total of four (4) days, and with fifty-six (56) days to be served in the Work Release Program, attending one (1) AA meeting per week for the period of probation, payment of victim restitution in an amount to be determined, and payment of fines and fees. The County jail sentence was ordered to run concurrent with Case No. RIM1900464.

4.

On or about November 2, 2020, in the Superior Court of California, County of Riverside, Case No. RIM1900464, Respondent was convicted on a plea of guilty for violation of Penal Code section 243(e)(1) (battery on a spouse/person whom defendant is cohabitating with), a misdemeanor. Respondent was placed on summary probation for thirty-six (36) months on certain terms and conditions, including, in part, commitment to the custody of the Riverside County Sheriff for sixty (60) days, with credit for time served of two (2) actual days, and two (2) days pursuant to Penal Code section 4019, for a total of four (4) days, and with fifty-six (56) days to be served in the Work Release Program, completion of a fifty-two (52) week Domestic Violence Program, having no negative contact with a protected party, and attending one (1) AA meeting per week for the period of probation, payment of victim restitution in an amount to be

determined, and payment of fines and fees. The County jail sentence was ordered to run concurrent with Case No. RIF1902258.

5.

In aggravation, on or about January 28, 2005, in the Superior Court of California, County of Riverside, Case No. RIM463923, Respondent was convicted on a plea of guilty for violation of Vehicle Code section 23152(a) (driving under the influence), and violation of Vehicle Code section 23152(b) (driving under the influence with a blood alcohol content of 0.08 percent or higher), both misdemeanors. Respondent was placed on summary probation for thirty-six (36) months on certain terms and conditions, including, in part, commitment to the custody of the Riverside Sherriff's Office for six (6) days, with credit for time served of one (1) day, and commitment to be served in the Sheriff Work Program, completion of a First Offender DUI program, suspension of license for twelve (12) months, and payment of fines and fees.

## SECOND CAUSE OF ACCUSATION (FAILURE TO REPORT CONVICTIONS)

6.

Pursuant to Section 10186.2 of the Code, a licensee shall report, in writing, "the conviction of the licensee, including any verdict of guilty, or plea of guilty or no contest, of any felony or misdemeanor" to the Department of Real Estate ("Department") within thirty (30) days of the conviction. Respondent failed to report in writing to the Department the convictions described in Paragraphs 3 and 4 above, within thirty (30) days of the conviction date.

7.

Respondent's failure to timely report the convictions constitutes cause under Section 10186.2 of the Code for the suspension or revocation of the license and license rights of Respondent under the Real Estate Law.

11	allegations of this Accusation and that upon proof thereof, a decision be rendered imposing
12	disciplinary action against all the licenses and license rights of Respondent TODD ELLIOTT
13	CAMARENA under the Real Estate Law, for the costs of investigation and enforcement as
14	permitted by law, and for such other and further relief as may be proper under other applicable
15	provisions of law.
