STIPULATION AND AGREEMENT

It is hereby stipulated and agreed by and between Respondents PLATINUM LOAN SERVICING INC. ("PLSI"), and RYAN JOE SOLOVY ("SOLOVY"), individually and as designated officer ("D.O.") of PLSI, (collectively "Respondents") and their attorney of record, Joshua A. Rosenthal, Esq., and the Complainant, acting by and through Laurence Haveson, Counsel for the Department of Real Estate ("Department"), as follows for the purpose of settling and disposing of the Accusation filed on July 17, 2023 ("Accusation") in this matter:

- 1. All issues which were to be contested and all evidence which was to be presented by Complainant and Respondents at a formal hearing on the Accusation, which hearing was to be held in accordance with the provisions of the Administrative Procedure Act ("APA"), shall instead and in place thereof be submitted solely on the basis of the provisions of this Stipulation and Agreement ("Stipulation").
- Respondents have received, read, and understand the Statement to Respondent, the Notice Concerning Cost of Audit, the Discovery Provisions of the APA, and the Accusation filed by the Department of Real Estate in this proceeding.

- 3. On July 24, 2023, Respondents PLSI and SOLOVY filed a Notice of Defense pursuant to section 11506 of the Government Code for the purpose of requesting a hearing on the allegations in the Accusation. Respondents hereby freely and voluntarily withdraw their Notice of Defense. Respondents acknowledge that they understand that by withdrawing their Notice of Defense, Respondents will thereby waive their right to require the Real Estate Commissioner ("Commissioner") to prove the allegations in the Accusation at a contested hearing held in accordance with the provisions of the APA and that Respondents will waive other rights afforded to them in connection with the hearing such as the right to present evidence in defense of the allegations in the Accusation and the right to cross-examine witnesses.
- 4. This Stipulation is based on the allegations contained in the Accusation. In the interest of expedience and economy, Respondents choose not to contest these allegations, but to remain silent and understand that, as a result thereof, these factual allegations, without being admitted, will serve as a prima facie basis for the disciplinary action stipulated to herein. The Real Estate Commissioner shall not be required to provide further evidence to prove said factual allegations.
- 5. This Stipulation and Respondents' decision not to contest the Accusation are made for the purpose of reaching an agreed settlement of this proceeding and are expressly limited to this proceeding and any other proceeding or case brought by the Department, or another agency of this state, another state, or the federal government, and otherwise shall not be admissible in any criminal or civil proceedings.
- 6. It is understood by the parties that the Real Estate Commissioner may adopt the Stipulation as his Decision in this matter, thereby imposing the penalty and sanctions on Respondents' real estate licenses and license rights as set forth in the below Order. In the event that the Commissioner in his discretion does not adopt the Stipulation, it shall be void and of no effect, and Respondents shall retain the right to a hearing and proceeding on the Accusation under all the provisions of the APA and shall not be bound by any admission or waiver made herein.
- 7. The Order or any subsequent Order of the Commissioner made pursuant to this Stipulation shall not constitute an estoppel, merger, or bar to any further administrative or civil

proceedings by the Department with respect to any matters which were not specifically alleged to be causes for the Accusation in this proceeding.

- 8. Respondents PLSI and SOLOVY understand that by agreeing to this Stipulation, that they agree to pay, jointly or severally, pursuant to Business and Professions Code Section 10148, the cost of the original audit which led to this disciplinary action. The amount of said cost is \$10,131.00.
- 9. Respondents PLSI and SOLOVY have received, read, and understand the "Notice Concerning Costs of Subsequent Audit." Respondents further understand that by agreeing to this Stipulation, the findings set forth below in the Determination of Issues become final, and the Commissioner may charge Respondent for the cost of any subsequent audit conducted pursuant to Business and Professions Code Section 10148 to determine if the violations have been corrected. The maximum cost of the subsequent audit shall not exceed 125% of cost of the original audit, or \$12,663.75.
- 10. Respondents PLSI and SOLOVY understand that by agreeing to this Stipulation, Respondents PLSI and SOLOVY agree to pay, jointly and severally, pursuant to Business and Professions Code Section 10106, the cost of the investigation and enforcement of this matter. As of September 6, 2024, the amount of the investigation costs is \$723.45 and the amount of the enforcement costs is \$3,704.40, for a total of \$4,427.85.

DETERMINATION OF ISSUES

By reason of the foregoing stipulations, admissions, and waivers, and solely for the purpose of settlement of the pending Accusation without a hearing, it is stipulated and agreed that the following Determination of Issues shall be made:

I.

The conduct, acts, and/or omissions of Respondent PLSI as described in the Accusation, constitute cause for the suspension or revocation of all real estate licenses and license rights of Respondent PLSI under California Business and Professions Code ("Code") sections 10145, and 10177(d) and/or 10177(g), and Title 10, Chapter 6, California Code of Regulations ("Regulation(s)") sections 2831, 2831.1 2831.2, and 2832.1.

The conduct, acts, and/or omissions of Respondent SOLOVY, as described in the Accusation, constitute cause for the suspension or revocation of all real estate licenses and license rights of Respondent SOLOVY under Code sections 10159.2, 10177(h), 10177(d) and/or 10177(g), and Regulation 2725.

ORDER

I.

All licenses and licensing rights of Respondent PLSI under the Real Estate Law are suspended for a period of forty-five (45) days from the effective date of this Decision and Order; provided, however, that:

- 1. Fifteen (15) days of said suspension shall be stayed upon the condition that Respondent PLSI petitions pursuant to Code Section 10175.2 and pays a monetary penalty pursuant to Code Section 10175.2 at a rate of fifty dollars (\$50.00) for each day of the suspension for a total monetary penalty of \$750 (\$50.00 per day X fifteen (15) days = \$750), and upon the following terms and conditions:
 - a. Said payment shall be in the form of a cashier's check made payable to the Department of Real Estate. Said check must be delivered to the Department of Real Estate, 651 Bannon Street, Suite 504, Sacramento, CA 95811, prior to the effective date of this Decision and Order. Payment of said monetary penalty should not be made until the Stipulation has been approved by the Commissioner.
 - b. No further cause for disciplinary action against the Real Estate license(s) of Respondent PLSI occurs within one (1) year from the effective date of the Decision and Order in this matter.
 - c. If Respondent PLSI fails to pay the monetary penalty in accordance with the terms and conditions of this Decision and Order, the suspension shall go into effect automatically. Respondent PLSI shall not be entitled to any repayment nor credit, prorated or otherwise, for money paid to the Department under the terms of this Decision and Order.

- d. If Respondent PLSI pays the monetary penalty and any other monies due under this Stipulation and Agreement and if no further cause for disciplinary action against the Real Estate license(s) of Respondent PLSI occurs within one (1) year from the effective date of this Decision and Order, the entire stay hereby granted pursuant to this Decision and Order, shall become permanent.
- 2. The remaining thirty (30) days of said suspension shall be stayed for one (1) year upon the following terms and conditions:
 - a. Respondent PLSI shall obey all laws, rules and regulations governing the rights, duties and responsibilities of a real estate licensee in the State of California; and,
 - b. That no final subsequent determination be made, after hearing or upon stipulation, that cause of disciplinary action occurred within one (1) year from the effective date of this Decision and Order. Should such a determination be made, the Commissioner may, in his discretion, vacate and set aside the stay order and reimpose all or a portion of the stayed suspension. Should no such determination be made, the stay imposed herein shall become permanent.
- 3. Respondent PLSI shall pay, severally or jointly with Respondent SOLOVY, the sum of \$4,427.85 for the Commissioner's reasonable cost of the investigation and enforcement which led to this disciplinary action within one-hundred and eighty (180) days from the effective date of this Decision and Order. Said payment shall be in the form of a cashier's check made payable to the Department of Real Estate. The investigative and enforcement costs must be delivered to the Department of Real Estate, Flag Section at 651 Bannon Street, Suite 504, Sacramento, CA 95811. Payment of investigation and enforcement costs should not be made until the Stipulation has been approved by the Commissioner. If Respondents fail to satisfy this condition in a timely manner as provided for herein, Respondents' real estate licenses shall automatically be suspended until payment is made in full, or until a decision providing otherwise, is adopted following a hearing held pursuant to this condition.
- 4. Pursuant to section 10148 of the Code, Respondent PLSI shall pay, severally or jointly with Respondent SOLOVY, the sum of \$10,131.00 for the Commissioner's cost of the audit which

In calculating the amount of the Commissioner's reasonable cost, the Commissioner may use the estimated average hourly salary for all persons performing audits of real estate brokers, and shall include an allocation for travel time to and from the auditor's place of work. Respondents shall pay such cost within sixty (60) days of receiving an invoice therefore from the Commissioner. Payment of the audit costs should not be made until Respondents receive the invoice. If Respondents fail to satisfy this condition in a timely manner as provided for herein, Respondents' real estate licenses shall automatically be suspended until payment is made in full, or until a decision providing otherwise, is adopted following a hearing held pursuant to this condition.

All licenses and licensing rights of Respondent SOLOVY under the Real Estate Law are suspended for a period of forty-five (45) days from the effective date of this Decision and Order; provided, however, that:

- 1. Fifteen (15) days of said suspension shall be stayed upon the condition that Respondent SOLOVY petitions pursuant to Code Section 10175.2 and pays a monetary penalty pursuant to Code Section 10175.2 at a rate of fifty dollars (\$50.00) for each day of the suspension for a total monetary penalty of \$750 (\$50.00 per day X fifteen (15) days = \$750), and upon the following terms and conditions:
 - a. Said payment shall be in the form of a cashier's check made payable to the Department of Real Estate. Said check must be delivered to the Department of Real Estate, Flag Section at 651 Bannon Street, Suite 504, Sacramento, CA 95811, prior to the effective date of this Decision and Order. Payment of said monetary penalty should not be made until the Stipulation has been approved by the Commissioner.
 - b. No further cause for disciplinary action against the Real Estate license(s) of Respondent SOLOVY occurs within one (1) year from the effective date of the Decision and Order in this matter.
 - c: If Respondent SOLOVY fails to pay the monetary penalty in accordance with the terms and conditions of this Decision and Order, the suspension shall go into effect automatically. Respondent SOLOVY shall not be entitled to any repayment nor credit, prorated or otherwise, for money paid to the Department under the terms of this Decision and Order.
 - d. If Respondent SOLOVY pays the monetary penalty and any other monies due under this Stipulation and Agreement and if no further cause for disciplinary action against the Real Estate license(s) of Respondent SOLOVY occurs within one (1) year from the effective date of this Decision and Order, the entire stay hereby granted pursuant to this Decision and Order, shall become permanent.

- 2. The remaining thirty (30) days of said suspension shall be stayed for one (1) year upon the following terms and conditions:
