STIPULATION AND WAIVER

13 Respondent.

14 I, TRAYSHUN DAUVIELE RICHMOND, Respondent herein, do hereby affirm that I have
15 applied to the Department of Real Estate for a real estate salesperson license and that to the best of
16 my knowledge I have satisfied all of the statutory requirements for the issuance of the license,
17 including the payment of the fee therefor.

18 I acknowledge that I have received and read the Statement of Issues and the Statement to
19 Respondent filed by Department of Real Estate, in connection with my application for a real estate
20 salesperson license. I understand that the Real Estate Commissioner ("Commissioner") may hold a
21 hearing on the Statement of Issues for the purpose of requiring further proof of my honesty and
22 truthfulness and to prove other allegations therein, or that she may in her discretion waive the
23 hearing and grant me a restricted real estate salesperson license based upon this Stipulation and
24 Waiver. I also understand that by filing the Statement of Issues in this matter the Commissioner is
25 shifting the burden to me to make a satisfactory showing that I meet all the requirements for
26 issuance of a real estate salesperson license. I further understand that by entering into this
27 Stipulation and Waiver I will be stipulating that the Commissioner has found that I have failed to

1 make such a showing, thereby justifying the denial of the issuance to me of an unrestricted real
2 estate salesperson license.

3 I hereby admit that the allegations of the Statement of Issues filed against me are true and
4 correct and request that the Commissioner in her discretion issue a restricted real estate salesperson
5 license to me under the authority of Section 10156.5 of the Business and Professions Code ("the
6 Code").

7 I am aware that by signing this Stipulation and Waiver, I am waiving my right to a hearing and
8 the opportunity to present evidence at the hearing to establish my rehabilitation in order to obtain
9 an unrestricted real estate salesperson license if this Stipulation and Waiver is accepted by the
10 Commissioner. However, I am not waiving my right to a hearing and to further proceedings to
11 obtain a restricted or unrestricted license if this Stipulation and Waiver is not accepted by the
12 Commissioner.

13 I agree that by signing this Stipulation and Waiver, the conditions, limitations, and restrictions
14 imposed on my restricted license, identified below, may be removed only by filing a Petition for
15 Removal of Restrictions ("Petition") with the Commissioner, and that my Petition must follow the
16 procedures set forth in Government Code Section 11522.

17 I further understand that the restricted license issued to me shall be subject to all of the
18 provisions of Section 10156.7 of the Code and to the following limitations, conditions and
19 restrictions imposed under authority of Section 10156.6 of the Code:

- 20 1. The restricted license shall not confer any property right in the privileges to be exercised
21 including the right of renewal, and the Commissioner may by appropriate order suspend
22 the right to exercise any privileges granted under the restricted license in the event of:
 - 23 a. The conviction of Respondent (including a plea of nolo contendere) of a crime which
24 is substantially related to Respondent's fitness or capacity as a real estate licensee; or

- b. The receipt of evidence that Respondent has violated provisions of the California Real Estate Law, the Subdivided Lands Law, Regulations of the Commissioner or conditions attaching to the restricted license.
- 2. Respondent shall not be eligible to petition for the issuance of an unrestricted real estate license nor the removal of any of the conditions, limitations, or restrictions attaching to the restricted license until two years have elapsed from the date of issuance of the restricted license to Respondent. Respondent shall not be eligible to apply for any unrestricted licenses until all restrictions attaching to the license have been removed.
- 3. With the application for license, or with the application for transfer to a new employing broker, Respondent shall submit a statement signed by the prospective employing broker on a form approved by the Department wherein the employing broker shall certify as follows:
 - a. That the broker has read the Statement of Issues which is the basis for the issuance of the restricted license; and
 - b. That the broker will carefully review all transaction documents prepared by the restricted licensee and otherwise exercise close supervision over the licensee's performance of acts for which a license is required.
- 4. Respondent shall notify the Commissioner in writing within 72 hours of any arrest by sending a certified letter to the Commissioner at the Department of Real Estate, Post Office Box 137013, Sacramento, CA 95813-7013. The letter shall set forth the date of Respondent's arrest, the crime for which Respondent was arrested and the name and address of the arresting law enforcement agency. Respondent's failure to timely file written notice shall constitute an independent violation of the terms of the restricted license and shall be grounds for the suspension or revocation of that license.

In the event of time constraints before an administrative hearing, Respondent can signify acceptance and approval of the terms and conditions of this Stipulation and Waiver by emailing a scanned copy of the signature page, as actually signed by Respondent, to the Department counsel assigned to this case. Respondent agrees, acknowledges and understands that by electronically sending the Department a scan of Respondent's actual signature as it appears on the Stipulation and Waiver, that receipt of the scan by the Department shall be binding on Respondent as if the Department had received the original signed Stipulation and Waiver.

I have read the Statement of Issues filed herein and the foregoing Stipulation and Waiver signed by Respondent.
