15	It is hereby stipulated by and between KIMBERLY WAMIKA HENDERSON		
16	("Respondent"), and the Complainant, acting by and through Judith A. Buranday, Counsel for the		
17	Department of Real Estate ("Department"), as follows for the purpose of settling and disposing of		
18	the Statement of Issues filed on April 4, 2024, in this matter:		
19	Respondent acknowledges that Respondent has received and read the Statement of Issues and		
20	the Statement to Respondent filed by the Department in connection with Respondent's application		
21	for a real estate salesperson license. Respondent understands that the Real Estate Commissioner		
22	("Commissioner") may hold a hearing on this Statement of Issues for the purpose of requiring		
23	further proof of Respondent's honesty and truthfulness and to prove other allegations therein, or		
24	that she may in her discretion waive the hearing and grant Respondent a restricted real estate		
25	salesperson license based upon this Stipulation and Waiver. Respondent also understands that by		
26	filing the Statement of Issues in this matter the Commissioner is shifting the burden to Respondent

to make a satisfactory showing that Respondent meets all the requirements for issuance of a real 1 estate salesperson license. Respondent further understands that by entering into this Stipulation and 2 3 Waiver, Respondent will be stipulating that the Commissioner has found that Respondent has failed to make such a showing, thereby justifying the denial of the issuance to Respondent of an 4 unrestricted real estate salesperson license. 5

Respondent hereby admits that the allegations of the Statement of Issues filed against 6 Respondent are true and correct and requests that the Commissioner in her discretion issue a 7 restricted real estate salesperson license to Respondent under the authority of Section 10156.5 of 8 9 the Business and Professions Code ("Code").

Respondent is aware that by signing this Stipulation and Waiver, Respondent is waiving 10 Respondent's right to a hearing and the opportunity to present evidence at the hearing to establish 11 Respondent's rehabilitation in order to obtain an unrestricted real estate salesperson license if this 12 Stipulation and Waiver is accepted by the Commissioner. However, Respondent is not waiving 13 Respondent's right to a hearing and to further proceedings to obtain a restricted or unrestricted 14 license if this Stipulation and Waiver is not accepted by the Commissioner. 15

Respondent agrees that by signing this Stipulation and Waiver, the conditions, limitations, and 16 restrictions imposed on Respondent's restricted license, identified below, may be removed only by 17 filing a Petition for Removal of Restrictions ("Petition") with the Commissioner, and that 18 Respondent's Petition must follow the procedures set forth in Government Code Section 11522. 19

20 Respondent further understands that the restricted license issued to Respondent shall be subject to all of the provisions of Section 10156.7 of the Code and to the following limitations, 21 conditions and restrictions imposed under authority of Section 10156.6 of the Code: 22

23 1. The restricted license shall not confer any property right in the privileges to be exercised 24 including the right of renewal, and the Commissioner may by appropriate order suspend 25 the right to exercise any privileges granted under the restricted license in the event of:

1	a. Respondent's conviction (including a plea of nolo contendere) of a crime which
2	bears a substantial relationship to Respondent's fitness or capacity as a real estate
3	licensee; or
4	b. The receipt of evidence that Respondent has violated provisions of the California
5	Real Estate Law, the Subdivided Lands Law, Regulations of the Commissioner, or
6	conditions attaching to the restricted license.
7	2. Respondent shall not be eligible to petition for the issuance of an unrestricted real estate
8	license nor the removal of any of the conditions, limitations, or restrictions attaching to
9	the restricted license until two (2) years have elapsed from the date of issuance of the
10	restricted license to Respondent. Respondent shall not be eligible to apply for any
11	unrestricted licenses until all restrictions attaching to the license have been removed.
12	3. With the application for license, or with the application for transfer to a new employing
13	broker, Respondent shall submit a statement signed by the prospective employing broker
14	on a form approved by the Department wherein the employing broker shall certify as
15	follows:
16	a. That the broker has read the Statement of Issues which is the basis for the issuance
17	of the restricted license; and
18	b. That the broker will carefully review all transaction documents prepared by the
19	restricted licensee and otherwise exercise close supervision over the licensee's
20	performance of acts for which a license is required.
21	4. Respondent shall notify the Commissioner in writing within seventy-two (72) hours of
22	any arrest by sending a certified letter to the Commissioner at the Department of Real
23	Estate at 651 Bannon Street, Suite 500-D, Sacramento, CA 95811. The letter shall set
24	forth the date of Respondent's arrest, the crime for which Respondent was arrested and
25	the name and address of the arresting law enforcement agency. Respondent's failure to
26	timely file written notice shall constitute an independent violation of the terms of the
27	restricted license and shall be grounds for the suspension or revocation of that license.
