5 3. I further agree that upon acceptance by the Commissioner, as evidenced by an appropriate order, all affidavits and all relevant evidence obtained by the Department in this matter prior to the Commissioner's acceptance, and all allegations contained in the Accusation filed in the Department Case No. H-42942-LA, may be considered by the Department to be true and correct for the purpose of deciding whether to grant relicensure or reinstatement pursuant to Government Code section 11522.

4. I agree that prior to, and only as a condition of a petition for reinstatement of my real
estate broker license made pursuant to Government Code section 11522 being granted, I will pay
the Commissioner's reasonable costs of the investigation and enforcement that led to the disciplinary
action in Department Case No. H-42942-LA. The amount of the investigation costs is \$814.25 and
the amount of the enforcement costs is \$2,600.40, for a total of \$3,414.65.

16 5. I freely and voluntarily surrender all my licenses and license rights under the Real
