14 **DECLARATION**

15 1. My name is GABRIEL PATRICK MUNGUIA LE VASSEUR, and I am
16 currently a licensed real estate salesperson. I am not being represented by an attorney in this
17 matter.

18 2. I have been informed by the Department of Real Estate that I am the subject of
19 an investigation of possible violations of the Real Estate Law, including, but not necessarily
20 limited to, Sections 490 and 10177(b) (for my 2024 conviction) of the Business and Professions
21 Code (“Code”), which could result in the filing of an Accusation to revoke or suspend my real
22 estate license.

23 3. In lieu of proceeding in this matter in accordance with the provisions of the
24 Administrative Procedure Act (Sections 11400 et seq., of the Government Code), I wish to
25 voluntarily surrender my real estate license issued by the Department of Real Estate
26 (“Department”), pursuant to Business and Professions Code Section 10100.2.

27 4. I understand that by so voluntarily surrendering my license, that I may be

1 relicensed as a salesperson or broker, or issued a new mortgage loan originator endorsement
2 only, by petitioning for reinstatement pursuant to Section 11522 of the Government Code.

3 5. The filing of this Declaration shall be deemed to be my petition to voluntarily
4 surrender my real estate salesperson license and shall also be deemed to be an understanding
5 and agreement by me that upon acceptance by the Commissioner, as evidenced by an
6 appropriate order, all affidavits and all other relevant statements, declarations and evidence
7 obtained during the course of the investigation prior to the Commissioner's acceptance may be
8 considered by the Department to be true and correct for the purpose of deciding whether or not
9 to grant reinstatement of my license pursuant to the provisions of Government Code Section
10 11522. This understanding and agreement is made without admitting or denying the truth or
11 contents of the aforementioned documents.

12 I declare under penalty of perjury under the laws of the State of California that
13 the above is true and correct and that this declaration was executed 07/01,
